## **INSTRUCTIONS FOR AUTHORS**

Annals of West University of Timisoara, Series of Biology publishes original research papers, review articles and short communications on all aspects of the theory and application of biology.

*Fields of interest:* Zoology, Botany, Cell Biology, Animal Physiology, Plant Physiology, Genetics, Biotechnology, Environmental Sciences, Microbiology, Behavioral Sciences, Molecular Biology, Conservation Biology, Biomedicine and health, Biology Teaching, Agriculture and preservation of natural resources.

Starting in 2011, the *Annals of West University of Timisoara, Series of Biology* is published electronically only.

Since 2012, *Annals of West University of Timişoara, ser. Biology* is a biannual journal. The journal encourages authors to frame their research questions and discuss their results in terms of the major questions of biology, medicine and agriculture, thereby maximizing the impact, spreading and value of their research. The papers must be of potential interest to a significant number of scientists and, if specific to a local situation, must be relevant to a wide body of knowledge in biology, medicine and agronomy.

This is an *open access journal* which means that all content is freely available without charge to the user or his/her institution. Users are allowed to read, download, copy, distribute, print, search, or link to the full texts of the articles in this journal without asking prior permission from the publisher or the author.

Don't number the pages and don't insert anything on header and/or footer.

#### TITLE: TNR, center, 13, caps lock, **bold**

The title should be short, specific, and informative.

#### AUTHORS: caps lock, center, 10, **bold**, *italic*

Academic degrees should not be included. The names, address and locations of institutions should be given for all authors.

# CHAPTERS (ABSTRACT, KEY WORDS, INTRODUCTION, MATERIALS AND METHODS, RESULTS AND DISCUSSIONS, CONCLUSIONS): justify, 10, bold, caps lock.

- The <u>abstract</u> (written text with Times New Roman font type, single line spacing, 10, *Italic*) of maximum 300 words should summarize the essential results and conclusions. The Abstract should be comprehensible to readers before they have read the paper, and abbreviations and reference citations should be avoided. Because these abstracts are used by secondary services, they should recapitulate in abbreviated form the purpose of the study and the experimental technique, results, and data interpretations. It is essential that the Abstract clearly states the biological importance of the work described in the paper. All important terms relevant to the content of the manuscript should be incorporated into the abstract and vague statements should be avoided.
- > Provide 5 <u>keywords</u> identifying the subject of your article.

- The <u>introduction</u> has to be a concise description of the background, rationale, aims and specific objectives of the paper.
- <u>Materials and methods</u> have to provide sufficient information to permit repetition of the experiment and/or fieldwork. A clear description or specific original reference is required for all biological, analytical, and statistical procedures. The detail description of study methods and type of equipment should be given only if are new; otherwise a short presentation is enough. All modifications of procedures must be explained.
- <u>Results</u> section must be a concise presentation of the finding of the study.
- Discussions section should deal with the significance of the results and their relationship to the aims of the paper. At the beginning of the discussion, summarise the main results, and show how they have addressed the research question. Compare study results with relevant findings from other published work. Discuss the limitations of the present study and any methods used to minimize or compensate for those limitations. Mention any crucial future research directions. The data should be interpreted concisely without repeating material already presented in the Results section. Authors have the option of combining the results and discussion into one section.
- Make sure that the *conclusions* are consistent with the results and are pertinent to the research question.
- List of <u>references</u> in alphabetical order, with the author's surname followed by the initial. Authors are responsible for the accuracy of the references. Material submitted for publication but not yet accepted should be noted as "unpublished data" and not be included in the reference list. All authors of a paper should be cited in the list of references. References "in press" shall only be cited when they have been accepted for publication. In the text, a reference should be cited by author and date. Examples are given here:

- Details of all funding sources for the work in question should be given in a separate section entitled 'Funding'. This should appear before the 'Acknowledgements' section. Acknowledge only persons who have contributed to the scientific content or provided technical support.
- The paper will be written with Times New Roman font type, without footnotes, single line spacing, justify, 11. Enter only *one* space at the end of sentences and after commas, semicolons, and colons. No space should be inserted before these punctuation marks. Complex equations should be entered using MathType. In the text, a reference should be cited by author and date and enclosed by round brackets; not more than one author may be cited per reference. If there are more use *et al*. All authors must be included for each cited item. Graphs and tables are inserted in the text. Titles are written above the tables and below the graphs. Images submitted with a manuscript for review should be minimally processed. Define all symbols and abbreviations used in the figure. Figures and legends should be intelligible without reading the text of the manuscript.
  - TABLE 1. (CAPS LOCK, 8, BOLD), title (8)
    - Provide spreadsheet files in Microsoft Excel (.xls). Tables should be embedded within the main document file and be numbered consecutively. A table should compare values. Every table *must* have a descriptive title and enough explanatory information so the reader can understand the data without reference to the text.

### • FIG. 1. (CAPS LOCK, 8, BOLD), title (8)

Provide image files as graphic image format (.gif), or JPEG (.jpg). All figures should be embedded within the text inside the main document file. All figures must have legends that *briefly* describe the data shown; details given in the text of the manuscript should not be repeated. Figures include line drawings, graphs, photographs, photomicrographs, or electrophoretic patterns. Symbols, arrows, or letters used in photomicrographs should contrast with the background so as to be clearly visible.
