Our publication ethics and publication malpractice statement is mainly based on internationally accepted best-practice guidelines for journal editors. The authors, the journal editors, the peer reviewers and the publisher - agree with standards of ethical behavior. Any form of plagiarism (including duplicate publication of the authors' own work, in whole or in part without proper citation), falsification or fabrication of data and misappropriation of the work of others (such as omission of qualified authors or of information regarding financial support) are strictly discouraged. Each author should have participated sufficiently in the work to take public responsibility for the content. Other than in exceptional circumstances the Journal does not allow addition or removal of author names after submission.

Authors submitting their works to the journal for publication as original articles confirm that the submitted manuscripts represent their authors' contributions and have not been copied or plagiarized in whole or in part from other publications (potential contributions include: acquisition, analysis and interpretation of data; conception, design, development of methodology; writing or revision of the manuscript). An administrative relationship, acquisition of funding, collection of data, or general supervision of a research group alone does not constitute authorship (ICMJE Recommendations 2013). All authors should participate in writing the manuscript by reviewing drafts and approving the final version. The order of authors is a collective decision of the authors or study group. All those who make a substantial contribution to a paper without fulfilling the criteria for authorship should be acknowledged. Our journal require authors to sign a statement justifying authorship (Newman & Jones, 2006; Osborne & Holland, 2009). This *Author Statement* must be printed, completed and signed with blue pen; then must be scanned and uploaded as a supplementary file in the submission process. It is the Corresponding (or "guarantor" - the principal author, or the person who takes responsibility for the integrity of the work as a whole) author's responsibility to ensure that all authors adhere to this policy.
